



League play will start on September 23, 2009 and end March 10, 2010. The weeks not played this year are Thanksgiving (November 25), Christmas (December 23), and New Years (December 30).

Attached is the schedule, rules, score sheet and initial roster of each team. Each team is asked to make their own copies of these documents. You will need at least 22 copies of the score sheet. I also ask that you leave a copy of the schedule and rules at your sponsored bar. **THOSE TEAMS NOT ABLE TO MAKE THEIR OWN COPIES, PLEASE LET ME KNOW AND I WILL PROVIDE THEM FOR YOU.**

IMPORTANT: HOME team must call in the score BY 7:00 a.m. Thursday, the morning after play. Phone number to use is on the bottom of the score sheets. The penalty for not calling will be \$5.00 the first offense and \$10.00 each time thereafter. PENALTY WILL BE ENFORCED

Player fees of \$48.00 will be due on or before December 9, 2009. This means you can pay prior to December 9, 2009 so there is no excuse for being late. If you do not have your fees in on time, you will not be allowed to play your matches till I receive them. I know some teams did not favor this rule – but it works. You can mail your players fees to me at my home address, 3430 Highway N, Rhinelander, WI 54501 or I will be at Pat’s bar the night of December 9 at 6:00 p.m. prior to play. There is also a weekly penalty of \$3.00 charged to your team for not paying on time. FOR NEW TEAMS: Players fees are from what you earn in wins each week and/or what you collect from your players each week. Each team is different on what they collect from their players – our team collects \$2/player as an example. Although, some sponsors, I don’t believe very many, pay for the players fee. You will have to work that out with your team.

Deadline for final rosters or changes to the roster I have on file is December 9, 2009. The final roster MUST be submitted with your player fees if I don’t already have it. If I do not receive a final roster, what I have on record will be used. If there are any changes to your roster, please leave a message on the answering machine or email me. It is important to have your telephone number on the roster sheet in order for me to contact you in case of any unusual circumstances, such as cancellations due to the weather, etc. Also, if any team member wants to be added to the email listing, please let me know.

Please read the rules, especially new teams, everything you need to know and should know is included.

IF YOU SEND ME AN EMAIL FOR WHATEVER REASON, PLEASE TITLE THE EMAIL “**POOL LEAGUE**”. It makes it easier for me to locate them. If you have any suggestions or concerns during the new year, please let me know. I will try to accommodate all valid requests.
